

**SUMMARY ANNUAL REPORT FOR  
HAYNES MECHANICAL SYSTEMS, INC. HEALTH & WELFARE BENEFITS PLAN**

This is a summary of the annual report of the Haynes Mechanical Systems, Inc. Health & Welfare Benefits Plan (Employer Identification Number 84-1318272, Plan Number 505) for the plan year 06/01/2023 through 05/31/2024. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Haynes Mechanical Systems, Inc. has committed itself to pay certain Medical and Employee Assistance Program claims incurred under the terms of the plan.

**Insurance Information**

The plan has insurance contracts with Cigna Health and Life Insurance Company and Affiliates, UnitedHealthcare Insurance Company, Vision Service Plan and Cigna Health and Life Insurance Company to pay certain Dental, Indemnity Contract, Vision, Life Insurance, Accidental Death & Dismemberment, Temporary Disability, Long-Term Disability, Hospital Care, Accidental Injury and Critical Illness claims incurred under the terms of the plan. The total premiums paid for the plan year ending 05/31/2024 were \$382,370.
